CONTEST ENTRIES WILL BE SUBMITTED USING THE ON-LINE ENTRY SYSTEM **UILFORMS.COM** ON THE REGION 3 WEBSITE. **INSTRUCTIONS FOR ENTERING CONTESTS ARE FOUND ON THE LEFT SIDE MENU UNDER "ENTER CONTEST"**.

All evaluation forms will be printed for you – YOU WILL NOT NEED TO PRINT YOUR JUDGES' FORMS!

***NOTE: We are no longer using the old summary sheets – it's very important that you read the information and instructions included on the instruction pages. There are specific instructions concerning items that still need to be printed and mailed to the Executive Secretary as well as other important information.***

You may mail or fax your form 1 before contest day or bring it to the contest, but it must be turned in before performance.

**CD RECORDING FEES for concert performances are included in the total entry fees as published.**

## **DEADLINES**

Check entry deadlines on schedule page. On-line entries must be submitted by the **official** deadline date.

**Buffer deadline dates** are for the convenience of a **contact person** in your district who may be responsible for coordinating entries and payment for an entire district.

**PLEASE NOTE: CHANGES IN MUSIC SELECTIONS FOR SOLOS AND ENSEMBLES WILL BE ALLOWED UNTIL 7 DAYS BEFORE THE CONTEST. NO EXCEPTIONS! NOTIFY BONNIE VIA EMAIL WHEN YOU NEED TO MAKE A TITLE CHANGE, INDICATING NAME OF STUDENT AND NEW TITLE.**

**CHANGES ON CONCERT MUSIC ARE ALLOWED UP TO 7 DAYS PRIOR TO CONTEST.**

## **PML AND CONSTITUTION & CONTEST RULES**

The new PML (for school years beginning 2007-2008-2009-2010) is accessible through uilforms.com as well as on the UIL state website ([www.uil.utexas.edu](http://www.uil.utexas.edu)) and the Region 3 website. The 2009-10 C&CR is also accessible on the UIL websites. Hard copies may be purchased from some music companies and from the UIL State Office.

Remember the importance of becoming familiar with the rules and regulations for the different contests regarding eligibility, music selection, copyright rules, gift-awards rule, etc.

**Check the on-line publications for official notices of corrections/additions, etc. to the C&CR and the PML. This is the only OFFICIAL source for corrections. Other helpful documents are also included on the state website. The PML is accessible through uilforms.com and will always include the latest revisions.**
